Precautions for storage and handling

- Keep out of reach of children.
- Do not transfer the medicine to a different container. (It may lead to misuse or alter the quality of the medicine.)
- The filling material in the bottle is to prevent the tablets from being damaged during transportation, so be sure to discard it before use.
- The bottle contains a deodorizer. Do not take it.
- If moisture gets on the tablets, part of the surface coating may dissolve, so do not drop water on them by mistake or touch them with
- Once opening the bottle, use it within 6 months to maintain the quality.
- Do not take the product after its expiration date.
